2. Service rights

If you are not able to join the CAR 2 CAR Forum, you are allowed to send one representative. Approved participants may apply to participate in the exhibition that complements the CAR 2 CAR Forum. This complementing service will be charged with an additional exhibition fee. Each approved participant receives access to the secured area of the CAR 2 CAR website allowing him/her to get detailed information about the event, the program and venue, to register online and to later download the released presentations shown during the CAR 2 CAR Forum. Beyond these services, there will be no other services available. Furthermore, approved participants will not have the right to use the CAR 2 CAR trademark. Approved participants will not have the right to transfer data received from the consortium to third parties.

3. Start and end of your service

The arbitral proceedings shall be held in English.

7.2 Should any provision of these terms and conditions prove to be invalid or incapable of fulfilment, or subsequently become invalid or incapable of fulfilment, whether in whole or in part, this shall not affect the validity of the remaining provisions of these terms and conditions. In such a case, the Parties shall be entitled to demand that a valid and practicable provision will be negotiated which most nearly fulfils the purpose of the invalid or impracticable provision.
