The following General Terms and Conditions settle the contractual relationship between the delegate and the CAR 2 CAR Communication Consortium (Organizer).

1. Venue

The venue is disclosed in the (updated) program and the online registration page of the CAR 2 CAR Forum.

2. Registration and terms of participation

Registration must be made online. A signature is not required. As the participation in events might be numerically limited the registrations will be handled on a first come first served basis.

After the receipt of a registration a confirmation and invoice will be sent out by e-mail. A general right to attend the CAR 2 CAR Forum does not exist. The CAR 2 CAR Communication Consortium reserves the right to decline attendance on an individual basis.

3. Benefits and payment

The registration fee includes one lunch per day, beverages, coffee breaks and an evening event if not stated otherwise in the program. All fees exclude value added tax at the current rate, unless disclosed otherwise in the program or the online registration page. The fee must generally be paid before the event upon receipt of the invoice. Arising bank charges are to be paid in full by the recipient of the invoice.

4. Cancellation

The participation may be cancelled free of charge 4 weeks prior to the event. 50% of the attendance fee will be charged for cancellations received up to 3 weeks prior to the event. Thereafter the CAR 2 CAR Communication Consortium will be entitled to charge the full amount. You may substitute another individual with no additional costs or penalty. Cancellation must be made in writing to CAR 2 CAR Communication Consortium c/o ITS mobility GmbH, Hermann-Blenk-Strasse 22 a, 38108 Braunschweig, Germany, or by e-mail to c2c-events@its-mobility.de or by fax to + 49 531 231721-19.

5. Event cancellation and changes

The organizer shall be entitled to cancel an event without stating reasons. In this case, the full attendance fee will be reimbursed. No further claims may be made. The organizer reserves the right to change the program provided such does not affect the overall character of the event.

6. Travel and accommodation

The delegate must organize and settle the expenses for the travel and accommodation by himself. For recommended accommodations have a look at the registration page of the event.

7. Liability

The organizer is liable for willful or grossly negligent action as well as for any infringement of major contractual obligations for which the organizer is to blame. In the event of negligence, the amount of liability for damages shall be limited to compensation of the contract's value. Liability for damages for injury to life or limb as well as product liability shall remain unaffected. Insofar as the afore-stated arrangement rules out or limits liability for damages, this shall also cover personal liability of the organs, of employees or of other members of staff, of representatives, of vicarious agents and the use of event documentation.

8. Event language and translation

The event language is English. A right to simultaneous translation does not exist.

9. Intellectual property rights

The Authors grant the publication right to the CAR 2 CAR Communication Consortium. Presentations and event documentation relating to the events are protected by copyright. Rights of use can only be granted by express written agreement. Under no circumstances must presentations or event documentation be duplicated, processed, passed on or used for the participant's own events. The participant consents irrevocably and without demanding remuneration to the organizer being entitled to use visual or sound recordings made of his person within the scope of the event for all current and future media.

10. Privacy policy

CAR 2 CAR Communication Consortium undertakes to treat all personal data in full compliance with the European General Data Protection Regulation (GDPR) and the Data Protection Adaptation and Implementation Act-EU (DSAnpUG-EU). In particular, the CAR 2 CAR Communication Consortium undertakes to treat your personal data confidentially and to not pass it on to third parties except for the purpose of order data processing. If requested, the CAR 2 CAR Communication Consortium will inform you about current events. The deletion from these distribution lists can be made at any time by telephone or written message to the organizer. 11. Place of fulfilment and court of jurisdiction

These Terms and conditions and any legal relations between both parties are governed by the law of the Federal Republic of Germany to the exclusion of the United Nations Convention on Contracts for the International Sale of Goods (CISG) . As far as legally permissible Braunschweig is the place of fulfilment and court of jurisdiction. Amendments and supplements to this Agreement must be in writing. This also applies to any change of this clause. No oral side agreements have been made.
